Complaint Reviewal

Docket # 2022-09

Allegation:

Ark. Code Ann. § 17-101-305 (7) Fraud or dishonesty in the application or reporting of any test for disease in animals;

Summary:

Complaint filed after Complainant had taken her dog to Respondent for a surgical procedure and subsequently the dog became blind. The complaint was filed after Complainant had a follow-up visit with another veterinarian and some blood work was forwarded that had omitted information but was subsequently resent with all the values.

Recommendation:

A motion was made, seconded, and passed to recommend to the Arkansas Livestock and Poultry Commission that the complaint be dismissed due to no violations of the Veterinary Medical Practice Act or rules. Dr. Pallone was not present for the vote.

Docket No. 2023-05

Allegation:

Ark. Code Ann. § 17-101-305 (5) Incompetence, gross negligence, or other malpractice in the practice of veterinary medicine.

Summary:

Complaint filed after Complainant purchased a horse from an auction that the Respondent had performed a brief examination prior to sale of the horse as requested by the seller. The complaint was filed after taking to regular veterinarian 46 days after taking ownership of the horse.

Recommendation:

A motion was made, seconded, and passed to recommend to the Arkansas Livestock and Poultry Commission that the complaint be dismissed due to no violations of the Veterinary Medical Practice Act or rules.

Complaint filed after Complainant took his 2-year-old dog to the Respondent for heartworm prevention shot, post heartworm treatment follow up and a rabies vaccine. Complaint was filed after clinic reached out for payment of services.

Recommendation:

A motion was made, seconded, and passed to recommend to the Arkansas Livestock and Poultry Commission that the complaint be dismissed due to no violations of the Veterinary Medical Practice Act or rules.
