Established business fees and renewal license fees will be based on the previous years purchases. Refer to the chart on page 8 of the Grain Dealer Law and Rules. The amount required based on your prior year's purchases should be sent in with the application.					
There is a blank on the new and renewal applications for purchases of Arkansas grain. This information is required. <i>If you are a new business, fill in the blank with a \$0.</i>

The minimum surety required is \$50,000.00. If you are a new business, once your application and financial statement are reviewed, you will be notified of the surety amor required to be licensed. The application packet contains a Bond form (GD-6), Letter of Credit form (GD-7) and a Certificate of Deposit (GD-8). Only one form of surety is require you are renewing, the surety on file must be up to date and valid.
