# Minutes of the Arkansas Water Well Construction Commission Meeting April 2, 2021

The teleconference meeting of the Arkansas Water Well Construction Commission was held Friday, April 2, 2021 at 9:00 AM

Commissioners in attendance: Vice-Chairman David Gilbert; Executive Secretary, Bruce Holland; Commissioners Lance Jones, David Washington, and Ernest Pender.

Absent: Chairman Mike McDermott and Commissioner Tom Hunt

Natural Resources Division staff in attendance included: General Counsel Wade Hodge; Associate General Counsel, Mike Bynum; Deputy Chief Fiscal Officer, Shelia Watts; Natural Resources Division Geologist Supervisor Jim Battreal; and Administrative Analyst, Jackie Broach.

Vice Chairman Gilbert called the meeting of the Arkansas Water Well Construction Commission to order.

#### Approval of Minutes:

Vice Chairman Gilbert presented the February 5, 2021 Commission Minutes. Commissioner Washington made a motion to accept the Minutes as presented, seconded by Executive Secretary Bruce Holland.

#### **Executive Secretary Report:**

Executive Secretary Holland reported that nothing has been debated or passed during this session of the Arkansas Legislature that would affect our agency. He also reported the agency employees are getting vaccinated against Covid-19.

#### Financial Report:

Sheila Watts, CPA, Deputy Chief Fiscal Officer, reported YTD Revenues of \$72,926.21; YTD Expenses of \$66,466.32; YTD Net Revenue of \$6,459.89; and Cash Summary total Cash \$475,458.36; Investments \$38,271.74; combined Total Cash Summary \$513,730.10. There were no refunds.

Commissioner Pender made a motion to accept the Financial Report as presented, seconded by Commissioner Washington. Motion carried.

#### Legal Report:

Department Managing Attorney Bynum reported that legal staff have drafted a proposed rule clarifying rule 3.2, which governs supervision at work sites, to require that a registered driller, pump installer, or apprentice be on site at all times.

Commissioner Pender made a motion to approve this clarification and initiate rulemaking with a second from Commissioner Washington. Motion carried.

Mr. Bynum stated that the next step would be that the rule would be published for a 30-day comment period. If there are any public comments, they would be summarized and given to the Commission. The Commission will be able to make changes to the proposed rule based on comments if it so chooses. He would then recommend a motion to vote based on the final proposed rule. After this, it would go to the Governor, then to the legislature for approval.

We answered 35 calls and emails from the public and contractors on rules, regulation, and database searches for well information since the last meeting.

Inspector Jacob Harvey stated that the Groundwater Division would be doing well data collection with USGS and NRCS. He stated that he would also be making contractor visits during this time. He reported that there was a lot of new construction in Northwest Arkansas and Groundwater Supervisor Jim Battreal would be checking in on them in the following weeks.

Inspector Harvey also stated that would be investigating unlicensed pump installers in a couple counties.

Commissioner Pender suggested using an app called Land Glide as a useful tool in locating wells. Groundwater Supervisor Battreal responded that USGS is working to have a hand-held device in the field that the contractor could enter data directly into their phones. Commissioner Pender responded that hand-held devices are very accurate
